Notice to California Retailers

California Proposition 65 Consumer Warnings

Based on our experience, we do not believe that our products when used as intended, present an exposure risk by ingestion, inhalation or absorption through the skin, to any of Prop 65's current list of chemicals. Nonetheless, out of an abundance of caution in the event our MiTek products are misused or used in ways we do not foresee, we are taking the precaution of placing a short-form Prop 65 warning on the labels of our products, and in some instances, on the products themselves or with signs posted in the California retail locations where our products are sold to consumers without labels.

All MiTek products manufactured and packaged for retail sale to consumers will carry the short form Prop 65 warning for the specific chemical associate with that specific product. The warning will be on the lower portion of products packaged in cartons and stickered directly to products which are sold loose or not in cartons. **See visual examples in attached Retail Placement Guide.**

In certain display sets, retailers remove our products from their cartons and sell to consumers via bins or other merchandising means. In this case the warnings that are on the cartons are not displayed. Prop 65 states retailers "are required to provide a "clear and reasonable" warning before knowingly and intentionally exposing anyone to a listed chemical." To ensure compliance, we offer **warning cards** and **stickers** with the Prop 65 short form warnings which must be used to meet the requirements for clearly notifying the consumers. Out of an abundance of caution we list the most severe warning of "cancer and reproductive harm" on these. Below are examples of the warning cards and stickers. **See Retail Placement Guide included with this letter for placement within your store sets.**

If a MiTek product does not display a warning, it does not meet the requirement mandating a warning based on the Prop 65 guidelines. This includes products with no hazardous chemicals associated with the product, it is not a consumer product or in cases it may be a distributed product from a third party which meets the safe harbor requirements.

Included in the package are 250 cards and stickers to ensure you are compliant by the **August 30, 2018 date**. Additional cards and stickers can be requested by contacting your local MiTek Sales Manager or the Customer Service number below.

These warning cards or stickers should be in place **no later than August 30, 2018**. We thank you in advance for your cooperation with this important task. If you have any questions or concerns about the Prop 65 warning or display of the shelf signs, please contact your MiTek Sales Manager.
